



## 2012 Dance Share

OhioDance Festival April 27, 2012

*The OhioDance Festival Dance Share is an informal process for student choreographers to show their work and receive valuable feedback about their process. The share will consist of a performance of selected pieces followed by a student discussion facilitated by Marlene Leber, Director of Dance Hathaway Brown School, and Kelly Berick, Director of Firestone High school Dance Department. The Dance Share is conducted in a supportive, non-competitive and comfortable environment. Selected choreographers will present their work (5 minutes or less) followed by a 10 minute dance forum (discussion and feedback of your work). We look forward to seeing what you have created.*

### **Eligibility and Selection Process**

1. The 2012 OhioDance Festival "Dance Share" will take place at BalletMet in Columbus, Ohio on April 27, 2012 from 4:30p.m.-6:30p.m. All Ohio-based professional and pre-professional members of OhioDance are eligible to apply. Students must be between the ages of 15-22 years old and must be a current member of OhioDance. Only individual or students of organizational members of OhioDance may apply.
2. A panel of OhioDance Board of Trustees will select the performers.
3. Those selected will be notified by February 28, 2012. Upon selection an agreement will be sent. Artist's under the age of 18 must have an adult representative sign the agreement.
4. The Dance Share is free to all eligible, registered participants of the OhioDance festival. Young choreographers wishing to attend only the Dance Share will need to pay a \$25.00 flat fee for each submission.

### **Application process**

Please submit the enclosed application with a clear description of your work. This can be a work-in-progress or a finished work, but it should be no longer than 5 minutes in length.

### **The application for the Dance Share must be received by February 10, 2012 and must include the following:**

1. The applicants name and contact information, dance title, choreographer's name, music, dancer's names, length, and brief description of the piece. Including a sample DVD is encouraged but not mandatory. DVD's may be recorded rehearsals or performances of completed pieces or works-in-progress. Please consider the quality of your DVD including lighting, visibility, clutter and overuse of special effects.
